**President or Pope: Should an
Elected Secular Leader Play a
Spiritual Role?**

Religion has always played an important role in American life and politics. Candidates are asked questions about their personal beliefs, their positions on Church and State separation, and often refer to 'god' in their speeches. However, the role of president or any other elected official is defined in secular terms. With these titles come responsibilities that are limited to more worldly events. In recent years, this idea has been challenged vigorously by an administration that boldly claims to be "saving Americans, one soul at a time."

As part of this crusade, President Bush and Congress declared May 6, 2004 a national day of prayer. In his declaration (linked below) the President stated that the government "encourages Americans of every faith to give thanks for god's many blessings...." He even gives all the reasons we should pray:

1. To praise god for *his* mighty works, *his* gift of freedom. *His* mercy and his boundless love.
2. To acknowledge the sovereignty (supremacy of authority) of god.
3. Because scripture says (Christian scripture, of course—Psalms 145:18-20) "the lord is near to all who call upon *him*...*he* also will hear their cry and *save* them."
4. For the brave men and women of the US Armed Forces.
5. That the people of Iraq and Afghanistan may live in safety and freedom.
6. To ask god's blessings for our nation, granting us strength and wisdom.

In this Declaration, President Bush and Congress have overstepped their bounds. They have taken their secular, tax-funded positions and used them in a religious fashion—namely, telling people when to pray and what to pray for. These acts fall squarely outside the range of secular government and into the realm of family, church, and personal choices. All Americans, religious and secular, Theist and Atheist, should have serious misgivings about this out-of-bounds declaration. While there are historical precedents, such days of prayer, this does not automatically make these actions legal. Previous violations of the first amendment do not validate current or future ones. There is, also, significant evidence that many of the Founding Fathers had reservations about the use of days of prayer (Several examples are linked below from the website of Americans United for a Separation of Church and State.)

The National Day of Prayer Task Force, with its pseudo-connections to government, even goes so far as to recommend prayer positions: "...during your prayer time, use different worship postures: kneel, lift your hands, and fall on your face before Him [god]." This of course comes from the Christian Bible: "I spread out my hands to you; my soul thirsts for you like a parched land" (Ps.143:6). While this Task Force is not part of the government, it does receive significant support from government officials. Where in the Constitution does it allow the government to pressure Americans into praying, dictating when to pray, how to pray, and for what reasons to pray? Don't bother looking, such a statement is completely absent from the Constitution, and was not omitted by accident!

My Road to Atheism

The roots of my atheism stretch far back into my childhood, when I attended a Roman Catholic grammar school. I clearly recall that in the first or second grade, I was not able to understand a number of concepts put forth as unquestionable "truths" in my catechism. Specifically, the assertion that there is but one god, who exists in three persons — *i.e.*, father, son, and holy ghost, was too weird. After a good deal of thought on the matter, I gave up, considered the concept incomprehensible and let it go at that. The catechism held that god always was, is now, and always will be, which sorely tested my ability to understand the concept of eternity. I mean, how could anything have no beginning or end, how could it have always existed or continue to exist no matter how far one turned back time or advanced it into the future? It baffled me then and still does.

The notion of transubstantiation of bread and wine into the body and blood of Christ never made any sense, either. (The communion host, to me, was tasteless and insisted on stubbornly clinging to the roof of my mouth. It didn't taste like anyone's body!) You get the overall idea: the notions and assertions of Catholicism had to be taken on faith, because they're

patently ridiculous on any logical or rational level.

It was suggested that I attend Catholic high school, but I politely declined. Nine years of parochial school was all I could stomach. I needed to escape from the clergy and nuns. The seeds of doubt were deep in my mind but I kept them on the shelf until I reached sophomore year. At that point I stopped attending weekly religion classes. By then, I had acquired a degree of science and biology understanding, so the bible references and assertions of the parish pastor who taught the religion class seemed less plausible than ever. He was an aging, rabid anti-Communist and John Bircher. He also tried his damndest to convert my mother from being a lapsed, non-churchgoing Methodist to being a Catholic. No such luck; she knew better.

I parted ways with religion for good when I was a nineteen year-old college student by abandoning Sunday mass to pursue more worthwhile, worldly things.

Freed from the Burden of Fear and Guilt

Like most folks, I had Catholicism, or religion, beaten into my head at an early age, whether it was by the nuns threatening to slap me or the folks dragging my sister and me to church. I remember, when I was six years old, sitting in church thinking: "There's so much more I could be doing." I also recall thinking at that time that the whole world went to church on Sundays and worshiped the statue of a man hanging on a cross. I never got any straight answers to my questions as to who Jesus was and why I was there every week listening to the priest talk. I wasn't getting any satisfaction worshipping a statue so my inquisitiveness grew. Inquisitive children equate to dangerous thinking in the Catholic church.

I pictured a corporation profit & loss bar in my head and thought: "Gee, it went down, the bar is bent. Oh, I remember I swore at my sister last week, but then it went back up again, didn't it?" These are not things a six year old should be up at night worrying about! But it happened to me because of those lies and stolen stories drilled into me that I now know are a carbon copy of

Mithraism. A friend once said to me, "Religion is based on guilt and fear; it's the ultimate thought police." He was right.

In July of 2000, a summer semester of Philosophy & Religion at the local community college proved to be my awakening. I had no idea what Philosophy meant at the time, but I had to take the course to graduate. Professor Abanza's class changed my life. All the answers I was looking for were there. I thought to myself one day in his class: "I can make up my own mind! I can do this! I get it! I understand The Three Realms of Thinking and The Universals.
