#### **DISMISSED WITH PREJUDICE**

Do you have one of those wacky friends? The ones with a deep, sincere, heartfelt conviction that Elvis still lives; that he is actually in seclusion preparing for his epic comeback? Busy rehearsing for the ultimate Elvis concert that will transform the world?

Your friend undoubtedly has an articulate rebuttal for every possible reason you can throw at him for dismissing the possibility that Elvis might still be alive. His death was staged. The witnesses are all in on it. The corpse in Graceland is a DNA-identical clone of him. He is being kept young by a chemical concoction that the pharmaceutical industry has suppressed.

Your friend probably turns the tables on your skepticism quite easily. How can you be so arrogant as to claim to know everything? Are you that close-minded? Surely you can't prove and therefore can't know for certain that he isn't still alive. If you are as scientifically open-minded as you claim you must admit some possibility that he might still be alive. Surely you can admit that reasonable people can disagree on this unless you believe he is dead purely as a matter of faith. The only intellectually honest position on this question must be agnosticism.

Your friend points to several well-regarded scientists who admit that it is possible Elvis is alive. He recommends a plethora of scholarly books that debunk all those fallacious "scientific" arguments claiming that Elvis is dead or perhaps your friend has a different but similarly wacky belief that he clings to and argues for with great passion.

All that was my way of setting the stage for the real point of this article - that I do not need to read any of those books purporting to prove that Elvis might be alive. Elvis is dead. Period. Any book that starts with the premise that he may still be alive is necessarily idiotic. There is no need for me to actually read them in order to legitimately dismiss them out of hand. Good scientists dismiss an infinite number of implausible claims all the time every day.

So there is no need for me to entertain arguments about how Elvis might still be alive. And there is no reason for me to read a book that starts with the premise that Elvis is alive or the Holocaust did not happen or the Moon landing was faked or alien overlords built the pyramids. I can dismiss them all out of hand without even reading the book jacket. The only reason to read them may be if your interest is in studying delusional thinking or the infection of magical thinking amongst otherwise healthy individuals.

And I have read a great many of these books that purport to present a logical or scientific argument for at least allowing the possibility that god might exist. When I wrote my book *Belief in Science and the Science of Belief*, I took the time to slog through a four-foot stack of books that undoubtedly made Amazon the lucrative enterprise it is today. It was largely a waste of time and money on my part. Believers have had two millennia to come up with arguments so there are simply no new ones to be found.

As a concrete example, I bought several books on Neurotheology. I did the world a service by throwing them out rather than reselling them. Written by Andrew B. Newberg and a host of his followers, these books typically spend 250 pages citing brain imaging and cognitive studies related to belief and god. Their real goal is to establish their science creds so that you will believe them when, in the last 50 pages, they leap to outlandish claims that go something like "since we have clearly evolved to believe in god, the only conclusion must be that god himself designed us to believe in him."

The only conclusion is that this is an idiotic conclusion. But then again what can you hope to get from any author that starts from the silly premise that god exists and works backwards?

Religious books purporting to be scientifically legitimate examinations of the "evidence" for god pop up on Amazon every day like so many weeds. I can't read them all but I can still dismiss them all out of hand. There simply is no god, can be no god, and therefore every book claiming to argue this point is necessarily as idiotic as books arguing that Elvis is alive and well and living in a secret wing of Graceland.

And thus, dear reader, we finally reach the heart of my dilemma: Do I read these silly books and respond to them or do I simply ignore them?

Ignoring them is not easy. If no one pushes back on them, they seem to win the argument. And there are so many of them saying the same silly things that many readers mistake quantity as an indication of quality. On the other hand, the time for engaging in these silly debates is over. At this stage of the atheist movement, we must move past engaging in and thereby legitimizing these ridiculous debates. We should give no more consideration to religious ideas than we do to racist ideas or homophobic ideas or sexist ideas or the idea that Elvis is alive and well.



Still, it's hard to resist getting sucked in. Recently a new book appeared on Amazon called *Can Science Explain Religion* written by a priest who is also a Professor of Religion. It apparently "debunks" the very theory of the evolution of belief that I present in my own book. Do I buy this and read it so I can credibly criticize it and defend my position, and thereby risk encouraging this nonsense? Or is it best not to even respond and hope that the rest of the country follows my sensible example?

# Do I read these silly books and respond to them or do I simply ignore them?

After struggling with this dilemma for many years, I have come to believe that refusing to engage is the best strategy moving forward. Engaging in further debate with them only feeds the beast. Like booing Donald Trump at a rally.

It's not an easy course of action nor is it without risk or criticism. But in science, we must first ask whether our basic assumptions are valid before we enter into discussions of the resulting questions. We must not let ourselves get caught up in grand debates over how Santa manages to deliver all those presents in one night when the very premise of Santa is pure fantasy.

And that is how we should respond to these books and these arguments—by dismissing them out of hand and with great prejudice and by refusing to entertain dependent arguments arising out of purely implausible assumptions.

# WHY DO RELIGIONS KILL OTHER RELIGIONS TO SEE WHO HAS THE BEST GOD?

Religion can do a great job helping believers discern right from wrong and helping them relate kindly and justly to other people. And it can stiffen their will when they face unjust suffering for their faith. I was taught these things when I studied Christian ethics; they continue to motivate me in my work as an ethics professor today. But hard experience has me seeing the negation of these claims more clearly than I did at the beginning of my journey.

Now I see that religion can sometimes do a very poor job of helping believers discern right from wrong—or in helping them relate kindly and justly to others. And it can also persuade people that the rejection of their hurtful or ill-considered convictions is actually martyrdom for God's Truth, leaving them even more entrenched in their destructive beliefs.

My two most inspiring teachers of Christian ethics in the 1980s were the Baptist Glen Stassen of Southern Baptist Seminary and the Lutheran Larry Rasmussen of Union Seminary. They knew each other and shared scholarly interests that shaped me as well: the Nazi period in Germany; the extraordinary life of the scholar-pastor-resister Dietrich Bonhoeffer; the challenge of overcoming racism; and opposing the nuclear arms race during the Cold War.

Both men taught me an essentially hopeful vision about the role that Christian convictions can play in making society better. Their faith had been impacted very deeply by the lessons of the Nazi period; it honored Dietrich Bonhoeffer for standing fast against Nazi seductions when so many of his fellow Christians surrendered their souls; it resisted America's own racism; and rejected the idea that more nukes would make the world safer.

My own dissertation focused on that small minority of Christians who rescued Jews during the Holocaust. What kind of character and faith motivated these people who risked their lives while their neighbors stood by indifferently? Thus, I have spent much of my career trying to teach "rescuer Christianity," instead of "bystander Christianity."

But now, as a wizened old veteran of the fight, I sometimes struggle with discouragement. It's not just that many Christians fail to live up to the clear demands of Christian discipleship. It's that we can't even agree on what those demands are. We all say we believe in Jesus, but what we make of that belief is so marked by irreconcilable differences that I'm not sure we are in any meaningful way members of the same religious community.

I should have seen this more clearly all along. After all, could it really be said that a Dietrich Bonhoeffer who died resisting Hitler shared the same religion as the "Christians" who murdered children in Hitler's name? What religious commonality linked white Christian KKK members and Black Christians fighting for an end to segregation and lynching? And how much do protorture, Islamophobic Christians have in common with those who take the opposite path? A faith that stands with the crucified ones of this world is very different from a faith that does the crucifying. The question becomes not whether you say you follow Jesus, but which Jesus you follow.

Worst of all has been my recent discovery of versions of Christianity that actually make people worse human beings than they might otherwise have been. Here, churches, pastors, or individuals interpret Scripture or faith in such a way that they do more harm than they would do if they were just good old-fashioned pagans. I never anticipated that I would think: "If we could just keep people out of (such a version of) church, they would be better people."

Christian leaders wonder why Christianity in America is declining so steeply. Here's a reason: some highly visible versions of Christianity are so abhorrent that sensible people want nothing to do with Christianity or with the people who practice it.

The same, of course, holds true for abhorrent versions and followers of other religions. But that's their problem, and this one is mine.

On March 30, 2016, the FDA approved an update of the package label for mifepristone, the primary drug used to induce medical abortion. This important revision was long overdue as knowledge about the drug had advanced substantially since its initial approval in 2000. Within mere weeks, U.S. Rep. Chris Smith of New Jersey, a leading advocate for "God-given rights", and Senator James Lankford of Oklahoma, who believes that freedom is "given to us by God", rallied the support of 73 fellow Congressional legislators to launch an effort to harass both the FDA and the scientists involved in the research under the pretense of concern for women's health.a gorilla).
